



From the Office of the Synod Secretary

The 32nd Assembly of the UCCSA in Zimbabwe is now something of the past. I was inundated with questions about the logic for having the Assembly in a country with much turmoil and suffering. Media reports made it even worst. This resulted in many people not availing themselves to go to the Assembly. The SA Synod ended with only 60 % of our delegation.

The people of Zimbabwe, however, were very determined to host the Assembly successfully. Some even referred to it as their birth-right to host the Assembly.

We were accommodated in the homes of members in Bulawayo. These humble people gave their best with the limited resources available and under the most difficult political and economic circumstances. The Zimbabweans were honoured to host the Assembly. Rev Ndlovu and the church in Zimbabwe really made us proud.

On the other hand the courage of the Zimbabweans makes you feel so ashamed when you think that many of us were hesitant to attend the Assembly, worried whether there will be enough food, water, etc. It reiterates how much we can be thankful to God for what we have.

This calls to mind a story I once read. As a deadly tornado ripped through Will County, Illinois, a young father sat cradling his infant

child, born just 3 weeks before. When the fierce, howling winds finally subsided and calm had returned, the man’s house was gone. And so was his baby. But according to the news report, the father found his child in a field near his house – alive and well! And so was the rest of his family.

When asked by a reporter if he was angry that he had lost everything he owned, he replied, “*No, I just thank God I have my baby and my family. Some people don’t have that. Nothing else is important.*”

Often it takes times of tragedy to remind us what really matters in life. When things are going well, we can easily get preoccupied with what we own. We become tied to so many non-essential, unimportant things. We tend to grow overly concerned about cars, houses, furniture, appliances, clothes and countless other trappings of modern life. But when life is reduced to the essentials, as it is in Zimbabwe, we recall again that life is enough reason to praise God.

Going to Zimbabwe at this time was very special and believe me, a massive encouragement to our friends across the borders. We can now only express our gratitude to God for the people of Zimbabwe for their hospitality and friendship.

NEW PRESIDENT-ELECT

The South Africa Synod is honoured to be able to have nominated the Rev Simon Zazaza for the position of President-Elect of the UCCSA. Rev Zazaza was unopposed elected at the recent Assembly in Zimbabwe and will take over the Presidency from the Rev Patrick Coltman in 2005.

Simon is currently the minister at Trinity United Congregational Church in Yeoville, Johannesburg. He is most probably the youngest President (Chairperson) of the UCCSA.

Rev Adora Lee

The UCCSA accepted an offer from Common Global Ministries to accommodate an HIV/AIDS Co-ordinator for Southern Africa and welcomed **Rev Adora Lee** at the recent Assembly in Bulawayo.

Rev Lee will devote a third of her time to the UCCSA and will be based in the UCCSA offices in Brixton. She is available to all constituencies of the UCCSA. The remaining two thirds will be shared between the Uniting Presbyterian Church and other partners of Common Global Ministries in Lesotho and Swaziland.

She is very keen to work with our constituencies. Among other things Rev Lee will assist with:

- * Co-ordinating AIDS ministries in the UCCSA.
- * Developing a network of AIDS ministries in the UCCSA.
- * Regions and Local Churches to develop and implement HIV/AIDS initiatives.
- * Regions and Local Churches to develop project proposals and analysis for HIV/AIDS projects.

Rev Scott Lovaas

The UCCSA accepted another offer from Common Global Ministries to accommodate the **Rev Scott Lovaas** who is based in Cape Town. Different possibilities for the use of Scott's skills and talents are being pursued by the UCCSA Mission Council. His wife, Anne Marsh, is working with the Rondebosch United Church.

His first task was to create a Deacon's Handbook for deacons in local churches. The handbook would be informative and would give guidelines to help individual deacons with worship and pastoral care. This is done in conjunction with the UCCSA Theological Committee.

Regions and Synods should feel free to make use of Scott's skills for such training. The idea is that deacons can use this handbook prior or during a visit.

Chief Albert Luthuli Legacy Project

Under the ministerial presence of Rev Scot Couper the construction on the Groutville church is scheduled to be completed on 30 November 2003.

An *ecclesiastical opening* of the church structure as part of the Chief Albert Luthuli Legacy Project is scheduled for the 16th December 2003. This will include a new adjacent building.

The event will concentrate on the foundation of the church (a tribute to Rev Aldin Grout and American and South African co-operation through mission), justice (Luthuli will be mentioned to emphasise the church's struggle against Apartheid), congregationalism in Southern Africa, contemporary denominational partnerships and most importantly, the local church at Groutville. The launch of the Chief Albert Luthuli Leg-



acy Project will take place on the 21st March 2004. This event will have governmental, political, international, justice and of course, Chief Albert Luthuli foci to the event.

Arch-Bishop Desmond Tutu will ceremonially "launch" the 'church component of the project. The event promises to be a star-studded cast. Both the President of South Africa, Thabo Mbeki, and Nelson Mandela is hoped to be in attendance. Other dignitaries world-wide are invited.

The Groutville United Congregational Church is assisted with this project by the Department of Arts and Culture and the Minister of Arts and Culture, Dr Ben Ngubane.


